## **Architectural Accessibility**

Architectural accessibility of the buildings of the I.J. Paderewski Academy of Music in Poznań

The Academy of Music is headquartered in a complex of three buildings and a Student House in another location.

1. The lecture building at ul. Św. Marcin 87 is a three-story building that has 3 entrances: one main entrance and one technical entrance at the ground level from Plac S. Stuligrosza and an entrance from ul. Skośna. The main entrance to the building has a heated ramp for wheelchairs. The building has an elevator for the disabled. There is a toilet for the disabled on the first floor. On the entrance doors to lecture and utility rooms used by people with special needs there are placards in Braille, and these include halls, dean's offices, the rector's office, exits to the courtyard, and utility rooms.

2. The historic building at ul. Św. Marcin 87 / ul. Skośna is a three-story building that has 4 entrances to individual staircases from the inner courtyard, i.e. A1, A2, B, and C. There is no wheelchair ramp to the entrance staircases A1, A2, and C. The building has no elevator, except for staircase B. The entrance to staircase B is from the sidewalk level and provides wheelchair access to the library. The north wing with staircases A1 and A2 is connected to the lecture building which provides access for the disabled, except for the 3rd floor. There is no toilet for the disabled. The building is listed in the Register of Historic Monuments under No. A 275.

3. The Aula Nova Building at ul. Św. Marcin 87/ Plac S. Stuligrosza is a four-story building that has 2 entrances from the sidewalk level. Inside there is an elevator and a ramp for wheelchair users. A toilet for the disabled is located on the ground level.

Budynek zabytkowy, wpisany do rejestru zabytków pod nr A 131 i A 132, zlokalizowany w otoczeniu Starego Rynku The Student House of the Academy of Music is located in Poznań at ul. Wroniecka 19/20. It is a three-story building that has one entrance from the sidewalk level in ul. Wroniecka. The building has no elevator and no toilet for the disabled. It is a historic building listed in the Register of Historic Monuments under No. A 131 and A 132, located in the vicinity of the Old Market Square.

All of the above buildings can be entered with an assistance dog and a guide dog.

There are no induction loops in the buildings; only the S. Stuligrosz Auditorium and the Chamber Hall, in part B of the historic building, are equipped with an induction loop. There is a partial lack of signage in Braille or contrast or enlarged print signage for the blind and visually impaired.

The buildings of the Academy of Music in Poznań do not have any parking spaces, including no parking spaces for the disabled.
