Eligible candidates must:

1. Meet the requirements set out in Article 113 of the Act of July 20, 2018 – Law on Higher Education and Science (Journal of Laws 2018, item 1668, hereinafter referred to as the “Act”),
2. Hold a Master’s degree,
3. Have experience working as a pianist-accompanist,
4. Be available in terms of time.

3. Personal data is processed for the purpose of candidate recruitment and employment.
