## Information on Processing of Personal Data

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as GDPR), we inform you that:

4. We will process your personal data in order to organize and provide the Masterclass pursuant to Article 6(1)(c) of the GDPR.
5. The recipients of your data may include:
  - a. public authorities and state offices or other entities authorized under the provisions of law or performing tasks carried out in the public interest or in the exercise of public authority,
  - b. other entities that, on the basis of relevant agreements signed with the I.J. Paderewski Academy of Music in Poznań, process personal data whose Controller is the I.J. Paderewski Academy of Music in Poznań, in particular, entities providing IT services to the Controller.
6. Your personal data may be transferred to third countries after it is posted on social media platforms such as Facebook or YouTube.
7. Your personal data will be stored until the end of the Masterclass and erased within one year of its completion.
8. Under the GDPR, you have the right to:

  - b. object to your data;
  - b. rectify (amend) your data;
  - c. restrict processing, transfer or erase your personal data;
  - d. lodge a complaint with the President of the Office for Personal Data Protection.
9. It is not mandatory for you to provide your personal data, but failure to do so will prevent you from participating in the Masterclass. We will not make automated decisions based on your personal data, including in the form of profiling.
