

**The Ignacy Jan Paderewski Academy of Music in Poznań**  
**Rector's Ordinance**  
**No. 7/03/2026 of 26<sup>th</sup> March, 2026**  
**on the Amount and Method of Payment for Educational Services**  
**for Academic Year 2026/2027**

Acting pursuant to Article 79 and Article 80 (2) and Article 163 (2) in conjunction with Article 23 (1) of the Act of 20<sup>th</sup> July 20, 2018, Law on Higher Education and Science (Journal of Laws of 2018, item 1668, as amended, hereinafter referred to as the "Act"), I hereby order as follows:

**§1**

For Academic Year **2026/2027**, I set the following tuition fees:

1. for repeating particular courses (subjects) due to unsatisfactory learning outcomes and for services related to classes not covered by the study plan, including classes complementing the learning outcomes necessary for taking up second-cycle (Master's) programme in a specific major:

individual classes:

- PLN **270.00** per hour (for classes taught by a professor);
- PLN **220.00** per hour (for classes taught by the Academy's professor);
- PLN **200.00** per hour (for classes taught by an assistant professor);
- PLN **150.00** per hour (for classes taught by an assistant or a lecturer);

group classes (2 to 4 participants):

- PLN **150.00** per hour (for classes taught by a professor);
- PLN **120.00** per hour (for classes taught by the Academy's professor);
- PLN **110.00** per hour (for classes taught by an assistant professor);
- PLN **80.00** per hour (for classes taught by an assistant or a lecturer);

collective classes:

PLN **75.00** per hour.

The calculated fee, prior to class assignment, is approved by the Rector on the Dean's request after financial approval by the Bursar;

2. for studies for foreigners obliged to pay fees in accordance with Article 79 (1), item 5 of the Act, except for those listed in Article 324 (2) of the Act and those studying under separate agreements (e.g. students from China): PLN **60,000.00** (PLN **65,000.00** – Artistic Lutherie) per academic year;
3. for Studies in English: PLN **60,000.00** (PLN **65,000.00** – Artistic Lutherie) per academic year, except for citizens of the European Union member states
4. for services connected with the learning outcome confirmation procedure: PLN 3,500.00;
5. for participating in a course leading to a pedagogical preparation for students on a fee-paying basis: PLN 2,000.00 (including PLN 200.00 entrance fee);
6. for issuing documents:
  - 1) PLN 20.00:

for issuing a copy other than one issued under Article 77 (2) of the Act:

- a copy of a diploma of graduation in a foreign language,
- a diploma supplement in a foreign language,

for issuing a duplicate of:

- a diploma of graduation,
- a diploma supplement;

2) PLN 22.00 – for issuing a student ID card;

3) PLN 26.00 – for certifying documents intended for legal transactions with foreign countries, referred to in Article 78 (1) of the Act,

4) fee for issuing a duplicate ID card is higher than the fee for the original by 50%;

7. the fee for accommodation at the Student Dormitory:

PLN 1,150.00 gross per person per month for a single room with a bathroom,

PLN 1,050.00 gross per person per month for a double room with a bathroom,

PLN 850.00 gross per person per month for a single room with no bathroom,

PLN 700.00 gross per person per month for a double room with no bathroom,

with the proviso that if the period of accommodation at the Student Dormitory in a given month is shorter, the fee is calculated proportionally.

## **§2**

Fees for educational services are paid within the deadlines and according to the rules specified in a separate ordinance of the Rector.

## **§3**

This ordinance comes into force on the day it is signed.
